1898 - British owned company Lloyd & Lloyd opens two branches in South Africa, one in Cape Town and the other in Kimberley. A & J Stewart & Menzies in Britain have a presence in South Africa being represented by Brown & McKenzie.

1903 - Seeing the need to consolidate their South African interests, the companies amalgamate to form Stewarts & Lloyds (South Africa) Limited and expand their branch network to include Bloemfontein, Durban, Port Elizabeth, East London and Johannesburg.

1947 - Immediately after the Second World War, in October 1947, Stewarts & Lloyds began to take a far more active interest in the Eastern Transvaal. In the initial stages the Eastern Transvaal was serviced from the Pretoria branch.

Mid 1990's - In the mid-nineties, Barloworld did an asset swop with Dorbyl and accquired the Stewarts & Lloyds brand name.

2001 - The Stockwell group accquired various branches from Barloworld, including the Stewarts & Lloyds name. The Stockwell group then renamed all the Stockwell branches under the Stewarts & Lloyds name.

TODAY - The national footprint having grown to 32 outlets, the product portfolio has grown from the traditional Stewarts & Lloyds offering to include a wide spectrum of steel products and added value services.




